DESCRIPTION

FIG. 1 is an angled top perspective showing front and right side of a product distributor embodiment of the present disclosure;

FIG. 2 is a right side view of the embodiment of FIG. 1;

FIG. 3 is a left side view of the embodiment of FIG. 1;

FIG. 4 is a top plan view of the embodiment of FIG. 1;

FIG. 5 is a bottom plan view of the embodiment of FIG. 1;

FIG. 7 is a back end view of the embodiment of FIG. 1;

FIG. 8 is an angled bottom perspective showing front and right side of the embodiment of FIG. 1; and,

FIG. 9 is an angled top perspective showing back and right side of the embodiment of FIG. 1.
